Due to our predominantly migrant farm worker population meetings are scheduled for 6:00pm. Any variance from that time would significantly reduce participation. Child care is offered for meetings but no transportation. Both our SAC and Parent meetings are held on Wednesdays. A calendar is presented in August that lists the meeting dates for the entire year so that parents may plan in advance. Parents are always welcome to make an appointment if they plan to miss a meeting. Our teachers also perform a home visit to each family by December 31<sup>st</sup>. Title 1 funds are used to reimburse mileage and other expenses incurred by the teachers.

Our first SAC meeting was attended by returning as well as new parents. Nominations were accepted for officer positions and the activities of the upcoming school year were discussed. The following meeting was held in October and officers were selected by secret ballot. The results were shared immediately. The committee then discussed and approved the SIP as well as A+ Recognition Funds that RCMA Wimauma Academy received for improving its school grade from "C" to "A".

Our SAC is comprised of members of the school, community, and parents with the majority of members being non-employees. All meetings are held in Spanish with translation as needed and guided by an agenda with minutes being recorded and placed in the task box along with sign-in sheets.

The Parent Involvement Goal of the SIP was planned using the end-of- year School Climate and Effectiveness survey as well as FCAT data. One of our targeted areas is School Decision Making and Advocacy.

A parent notice was sent during Pre-planning advising parents of our Open House. During the event parents had an opportunity to meet the teachers, visit classrooms, and discuss curriculum. Administration shared Title I information and advised parents of programs associated with Title I funding. Each and every meeting includes details of how parents can help children at home. Many of our parents cannot read or write in English so strategies are oftentimes a challenge. SAC and parent meetings are held monthly and include any Title I information that needs to be disseminated. The first meeting included a detailed description of all paperwork/forms that were to be sent home.

In addition to parent meetings, teachers are required to make at least one visit to each student's home. We are a community school so most of our families live close to the school. During this visit, curriculum, expectations and program details are explained. Parent-teacher-student compacts are also signed at this time.

Each quarter, the parent meeting includes distribution of report cards and conferences. Parents are encouraged to make appointments to speak with teachers at their and the teacher's convenience.
